The Presbyterian Church (USA) has a wonderful website at www.pcusa.org where you can read all about what the PCUSA is doing. It is also very educational. Today's educational brief that I am sharing with you from the website is regarding stewardship and per capita.

What Is Stewardship?

Stewardship is about making choices, as individuals and in community. It is more than giving money to the church. Stewardship is about being faithful disciples, caring for and managing all that God has given us. Stewardship is not just one part of Christian discipleship; it involves every aspect of life in all the stages of life.

Stewardship is the grateful response to God's grace and goodness. It requires a consideration of how our choices affect us and others, of how we can be good caretakers of the created world, and of how we can best serve God as disciples of Christ.

The Per Capita Budget

The payment of the per capita apportionment can be seen as a sign of healthy relationships within the church, giving tangible witness to the unity and wholeness promised to us in Jesus Christ, and is a way of sharing the costs that equitably belong to the whole Presbyterian Church community expressing the essential unity of the church.

It has been said that per capita apportionment is like a utility bill. Just as we pay for heat, light, water, and telephone in order to remain connected to the utility systems and benefit from the services provided, we also pay per capita so that the Presbyterian system can function on behalf of all of us. It is the necessary linkage in our connectional system.

Each presbytery is responsible for the timely payment of per capita for the current year. The Scioto Valley Presbytery faithfully pays their per capita apportionment for the churches in their presbytery. We have in turn the same responsibility to be good stewards.

This year our share of per capita is \$8,580.00. Session unanimously agreed to pay our full apportionment in 2017. Our church's share of per capita is based up total membership. If each member pays their portion of per capita in addition to their tithe it will decrease the burden to our ministry budget. The per capita apportionment per member this year is \$33.00. So, if you are a family of 3 and all of you are formal members on the roll book, the total for your family is \$99.00.

When paying your per capita apportionment please designated "per capita" on the memo line of your check or if paying via Push Pay select the tab labeled "per capita".

I pray that you will recognize the importance of our stewardship to the connectional church community in spreading the good news of the gospel through the Presbyterian Church (USA).
